

# **DRONE SHOW BOOKING POLICY – Lakshdeep Aviation**

Thank you for choosing Lakshdeep Aviation for your Drone Light Show.

This policy outlines booking terms, cancellation rules, weather conditions, safety guidelines, and refund eligibility.

---

## **1. Booking Requirements**

- Drone Show bookings **must be made at least 1 month (30 days) in advance**
  - Final concept, location, and event details must be confirmed **minimum 15 days before the show**
  - Any last-minute changes are subject to technical feasibility and additional charges
- 

## **2. Documentation & Permissions**

The client must ensure:

- Event location permissions
- Safety clearance (if required)
- Adherence to local police or municipal guidelines
- Compliance with any government rules applicable to the event location

(Lakshdeep Aviation will assist with technical documentation as needed.)

---

## **3. Weather & Government Restrictions**

Drone Shows are highly weather-dependent.

A show may be delayed, rescheduled, or cancelled due to:

- Rain, storm, fog, or high wind
- Low visibility conditions
- Government restrictions or orders
- Emergency situations
- Airspace clearance issues
- Security concerns
- Any condition unsafe for drone flight

Safety is our top priority.

---

#### 4. Cancellation & Rescheduling by Company

Lakshdeep Aviation reserves the right to postpone or cancel the show if safety or compliance is compromised.

If the show is cancelled due to weather or government instructions:

- Client may choose a **new show date**  
**OR**
- Request a **refund with deduction of transportation/logistics cost**

No compensation will be provided for external factors beyond company control.

---

#### 5. Cancellation by Client

If the client cancels:

- More than 15 days before event: **Refund issued after deducting planning and logistics cost**
  - Less than 15 days before event: **Partial refund** depending on expenses
  - Less than 7 days before event: **No refund**  
(Unless cancellation is due to government restrictions)
- 

#### 6. Show Safety Guidelines

Clients must ensure:

- Safe take-off/landing zones
- Controlled environment for the audience
- No obstacles, wires, or hazards in flight area
- Adequate security and crowd control
- Public announcements if required

No unauthorized person may enter the drone operation zone.

---

#### 7. Payment Terms

- All payments must be made via **online transfer or cheque only**
  - 50% advance is required to confirm the booking
  - Remaining 50% must be paid **15 days before the event**
  - Bookings not paid on time may be auto-cancelled
-

## **8. Intellectual Property**

All Drone Show animations, light sequences, drone formations, and show designs are property of Lakshdeep Aviation.

Reproduction or reuse without permission is prohibited.

## **9. Liability**

Lakshdeep Aviation is not responsible for:

- Changes in event timing by client
  - Venue issues
  - Weather unpredictability
  - Crowd management
  - Damage caused by interference by the audience or third parties
  - Government bans or restrictions
